- Landscape (horizontal) orientation
- High-resolution image (minimum 300 dpi; original camera or smartphone file preferred)
- JPEG (.jpg) or PNG (.png) format
- Minimum image size of 3000 pixels on the longest side (recommended for print quality)
- Photos should be in full colour
- Minor adjustments (brightness, contrast, colour correction, and cropping) are permitted.
- No AI-generated images, composites, excessive filters, or heavy digital manipulation.
- Photos must be the original work of the entrant and must not infringe on any copyright.
